Apotex is initiating a voluntary **RETAIL LEVEL** recall that addresses an issue with the product due to a potential GMP violation, and is asking all retail pharmacies to now inspect for and remove **BELOW LISTED LOT #'s** for the following product (No significant adverse health consequences are expected with these lots):

It is necessary to reformat the typical notification into tables due to the size of this recall.

Pharmacies are advised to quarantine and discontinue distribution of these lots. Further instructions will come directly from your distributor.

RelayHealth has responded by implementing a NotifyRx™ safety alert informing pharmacies of this recall at point-of-dispense when the claim is processed through the Intelligent Network.
